#### **Vacation Camp Important Notes:**

**Lunch:** To receive a lunch you must notify the Site Coordinator before 10:00am so we may coordinate effectively. If you arrive after 10:00am, please plan on providing a lunch. **Please, no peanut or nut products.** 

**Immunization Records:** All children attending AYCC Childcare programs, including Vacation Camps, must have an updated copy of immunization records on file. If you have not submitted a copy since September 2025, then we will need an updated copy. **December Vacation Camp**, only Atwood & Waterville sites will be available. Benton students will be registered for Waterville for this week.

Karate Camp Extended Care— this program is held on at the Waterville location and is for youth who are currently enrolled student with Club Naha Karate Do and need care before and after Karate Vacation Camp hours (9:00 am-3:30 pm). There is no form needed for Karate Vacation Camps, however, if before/after care is needed, this form is required and there is a \$10/day per child fee for this service. Our childcare staff or a black belt from Club Naha will be available to bring youth to and from each program. **Late Pick-Ups After 5:30 pm:** We will charge \$10.00 per 15 minute for late pick-ups.

**Refunds:** Children dismissed from any of our childcare programs will not receive any refund/credit and are not eligible to switch to another AYCC location. To remove a child from a week of care, the Childcare Coordinator must receive 2 weeks advance notice. If a two-week notice is not provided, the family will be held responsible for a two week paid notice. Under all circumstances, a paid two-week notice is required for removing the child from any of our childcare programs. A \$10 processing fee will be assessed for all refunds.
